Taylor Fights Pay Cut Due 96 on Staff

As a result of a recent ruling by the City's Civil Service Commission, ninety-six provisional employees of the four city colleges face salary cuts ranging from \$250 to \$1210 a year.

The 96 clerical assistants affected by the ruling were declared "eligible" by Civil Service in November, 1948; when the results of the first examination in nearly ten years were made known. One hundred and twenty-nine others failed to qualify and will be dropped; from their jobs early this month.

The eligible "provisionals" who wish to continue working at the colleges will have to accept a base salary of \$1,200, plus a cost-ofliving bonus of \$660. The wage cut would mean a reduction of from twelve to thirty-nine percent in income, since the present pay level is from \$1,450 to \$2,410 in base pay, plus the same \$660 bonus.

The Commission's action brought disapproval from several quarters. Taylor Objects

In a letter to Dr. Ordway Tead, Chairman of the Board of Higher Education, Robert L. Taylor. City College Registrar, criticized the ruling, stating that "obviously the shortsightedness that produced these circumstances serves to breed an unhappy relationship between the employee and the administration. As usual the public will suffer."





Writing in the premier issue of Clair Bee's "Basketball Annual," Begovich declares that "because of the great speed and race horse tactica, basketball of today is teaching the stage of no longer belonging to the player." As a cure he suggests that "the officials handle the ball after every scoring play allowing the defensive team to set up a natural defense." (This presumably would at least give the game to the officials who, I suppose, have as much right to it as anybody else.)

It should be quite clear to the objective observer that Matty has really hit on something. His remedy should be applied without delay for the fast break has already had a degenerative effect on the game.

Chief among the deplorable aspects of race horse basketball is its tendency to keep the short man in the game. This is intolorable to the purists who recognize that banketball is inherently a tall man's game. A slower brand of banketball would rid us of the penky dwarf who foully uses his speed to rob the long drink of water of him graceful dignity forcing him to scamper about the court, dragging his tongue, instead of posing nonchalantly, arms akimbo, in the key hole.

Moreover, today's fast game seems to have accelerated the slarming trend toward larger crowds of spectators. And these spectators behave in a most raucous manner. They seem to be unable to sit still and insist upon leaping about like a herd of anthrapoids. Most distressing. In the good old days of slow and easy basketball, one could calmly admire the virtuosity of the players while politely stifling a yawn or two instead of jumping up and down like an idiot with a hotfoot. You never had to worry about your blood pressure.

Indeed, Mr. Begovich does not go far enough. I would not limit this anti-speed business to basketball alone. Extend it to other sports, I say. Baseball could be vastly improved through the outlawing of base stealing. This infamous practice is most unfair to such horisehide artists as Yogi Berra and Johnny Mize. Then too, there should be a law to slow Buddy Young down to a crawl. His dazzling speed, besides not permitting the defense to get set, has caused more cases of eyestrain than City College's tecanology courses. And when we get through with baseball and football, we can go to work on horseracing. Mr. Begovich's suggestion has infinite possibilities.



Matty Begovich, that sterling baskethall referee of many campaigns, is still fighting the good fight. Writing in the premier issue of Clair Bee's "Basketball Annual," Begovich declares that "because of the great speed and race horse tactics, basketball of today is reaching the stage of no longer belonging to the player." As a cure he suggests that "the officials handle the ball after every scoring play allowing the defensive team to set up a natural defense." (This presumably would at least give the game to the officials who, I suppose, have as much right to it as anybody else.)

It should be quite clear to the objective observer that Matty has really hit on something. His remedy should be applied without ciclay for the fast break has already had a degenerative effect on the game.

Chief among the deplorable aspects of race horse basketball is its tendency to keep the short man in the game. This is intolerable to the purists who recognize that banketball is inherently a tall man's game. A slower brand of basketball would rid us of the penky dwarf who foully uses his speed to rob the long drink of water of his graceful dignity forcing him to scamper about the court, dragging his tongue, instead of posing nonchalantly, arms akimbo, in the key bole.

Moreover, today's fast game seems to have accelerated the clarming trend toward larger crowds of spectators. And these spectators behave in a most raucous manner. They seem to be unable to sit still and insist upon leaping about like a herd of anthrapoids. Most distressing. Then too, there should be a law to slow Buddy Young down to a crawl. His dazzling speed, besides not permitting the defense to get set, has caused more cases of eyestrain than City College's technology courses. And when we get through with naseball and football, we can go to work on horseracing. Mr. Begovich's suggestion has infinite possibilities.
